In order to vote, you **must produce identification** containing your name and current address for inspection. If you do not have identification, an Elector may vouch for you and they must produce the same form of identification. The identification must be one or more of the following:

Operator's / Driver's license or an Alberta Identification Card; photo identification issued by a Canadian government or agency, whether federal, provincial or local that contains the elector's name and address; bank / credit card statement or personal cheque; government cheque or cheque stub; income / property tax assessment notice; insurance policy or coverage card; letter from a public curator, public guardian or public trustee; pension plan statement of benefits, contributions or participation; residential lease or mortgage statement; statement of government benefits; utility bill; vehicle ownership, registration or insurance certificate; a letter or form (attestation) confirming that the person lives at the stated address, and the letter can be signed by any of the following authorized representatives of a: commercial property management company, correctional institution, First Nations band or reserve, post-secondary institution, facility that provides services to the homeless, or supportive living facility or treatment center

as required by Section 53 of the Local Authorities Election Act.
